TRANSPORTATION CONSENT AND RELEASE FORM

In consideration of **Leahurst College** granting permission for my son or daughter (a student or prospective student of Leahurst College) to be transported on school-authorized trips (including those trips to and/or from school for attendance on a regular school day) during the 2017/18 school year, I/We attest to all of the following representations; all of which I/we acknowledge and understand that Leahurst College is and will be relying upon to its detriment:

1. A student who will be transported to and/or from a Leahurst College event (including regular school days) must have this form completed and signed by all custodial parents and/or guardians and by the student, if 15 years of age or older. I/We attest that all custodial parents and/or guardians, and the student if 15 years of age or older, will have signed below before submitting this form to Leahurst College.

I/We understand, acknowledge, and agree that Leahurst College has made and will be making all transportation decisions in compliance with Ontario's *Highway Traffic Act*, and that such legislation and the regulations thereunder constitute our agreed standard of care in such transportation. No higher standard of care is either offered, promised, or provided. I also understand, acknowledge, and agree that all of Leahurst College's policies, procedures, and protocols apply to such transportation, just as same would apply to all other school activities and/or events, whether on-or-off school premises. Understanding and acknowledging same, I/we hereby give permission for our son or daughter to be transported in a Leahurst College bus or chartered bus (when necessary) to and from such activities and/or events (including travel to and/or from regular school days at Leahurst College).

4. I/We attest that I/we have fully explained to my/our son or daughter and informed them of the absolute importance and legal requirement of properly wearing at all times any available seat belts, and the risks (including temporary or permanent injury, and even death) if not so properly worn at all times. I/We attest that I/we have demonstrated the proper use and wearing of any available seat belts to my/our son or daughter, to the point where I/we can now attest that he or she has mastered same.

I/We understand, acknowledge, and agree that neither Leahurst College nor its driver may be held liable in any way for any injury (including death) or property damage as a result of my son's or daughter's transportation to or from any such activity or event. I/We agree to hold harmless Leahurst College and its driver from any claim by me/us, or my/our family, estate, heirs or assigns arising out of transportation to or from any such activity or event.

6. This written document constitutes the entire understanding concerning the subject matter hereof. All prior agreements, discussions, representations, warranties and covenants are merged herein. There are no warranties, representations, covenants or agreements, expressed or implied, between the parties except those expressly set forth in this written understanding. Any subsequent amendments or modifications of this understanding must be both in writing and acknowledged in writing by the signature of the Head of School of Leahurst College.

7. I/We acknowledge that I/we have read and understand this document, and I/we acknowledge that I/we have had sufficient opportunity prior to signing to obtain independent legal advice with respect to it.
